# SCHOOL BOARD MEETING MINUTES

- A. CALL TO ORDER: The meeting was called to order at 6:32 p.m. followed by the Pledge of Allegiance.
- B. ROLL CALL: Mr. Robinson-Chair present, Mr. Woodford-Vice Chair present, Mrs. Luker present, Mr. Atkinson present and Mrs. Eburn present. Student Representative Hannah Jay present.
- C. CHANGES TO THE AGENDA: Add School Board Recognition under D, Review of January 11, 2017 Special Meeting under E, and Warrant # 15294-98 in the amount of \$1,878.70. Also added under Action Items, 4. Contract for Home Support and 5. Contract with Bellevue School District. Mr. Atkinson made a motion to approve the changes to the agenda. Mrs. Luker 2<sup>nd</sup>. Motion carried.
- D. SCHOOL BOARD RECOGNITION: Superintendent Jay read Governor Inslee's Proclamation of Appreciation for Washington School Board Director's and handed out Certificates of Appreciation to each School Board Director thanking them for their service to the community.
- E. REVIEW OF JAN. 11, 2017 SPECIAL BOARD MEETING: Mr. Woodford stated that every school board member had not been given notice and therefore the meeting was in violation of state law. All action taken at the January 11, 2017 Meeting was invalidated and will need to be done again. The board agreed.
- F. ELECTION OF SCHOOL BOARD OFFICIALS: Mrs. Walker stated that the staff appreciated all that John Robinson has done as Board Chair, easy to contact and always calm sharing his ideas. She hopes whoever takes his place will be as easy to work with and as accessible. Nominee for Board Chair: Mrs. Eburn nominated John Robinson. Mr. Atkinson nominated Dan Woodford. Mrs. Luker 2<sup>nd</sup>. Mr. Woodford nominated Ginnie Eburn, she declined the nomination. Votes: 2 votes for Mr. Robinson and two votes for Mr. Woodford. Mr. Robinson cast the deciding vote for himself. Vice Chair: Mrs. Luker nominated Dan Woodford. Mr. Atkinson 2<sup>nd</sup>. All in favor. Legislative Representative: Mrs. Eburn nominated Bill Atkinson, no 2<sup>nd</sup>. Mrs. Luker nominated Mr. Woodford. Mr. Atkinson 2<sup>nd</sup>. All in favor.
- G. COMMUNITY LIAISON REPORT: Mr. Atkinson feels there should always be a staff member on site for Open Gym. If the person hosting Open Gym is not an employee they should not have a key.
